Gun Locker Rental Terms and Conditions

- Purpose of Locker Rental:** The gun locker provided by Shelby Paint and Hardware is intended solely for the storage of firearms and related accessories. The storage of any other items is strictly prohibited.
- Compliance with Laws:** The renter agrees to store firearms in compliance with all local, state, and federal laws. Shelby Paint and Hardware is not responsible for ensuring the legality of the items stored.
- Access:** The renter is responsible for maintaining the security of their locker. Only the renter, and individuals authorized in writing by the renter, are permitted access to the locker.

- Locker Maintenance:** The renter is responsible for keeping the locker clean and in good condition. Any damage beyond normal wear and tear may result in additional charges.
- Liability:** Shelby Paint and Hardware is not liable for any loss, theft, or damage to the contents of the locker. The renter is encouraged to obtain insurance to cover their stored items.

8. **Termination of Agreement:** The rental agreement may be terminated by either party with 30 days' written notice. Upon termination, the renter must remove all items from the locker and return the key (if applicable) to Shelby Paint and Hardware.
 9. **Inspection:** Shelby Paint and Hardware reserves the right to inspect the locker with reasonable notice to the renter, or without notice in the event of an emergency or suspected illegal activity.
 10. **Amendments:** Shelby Paint and Hardware reserves the right to amend this policy with 30 days' written notice to the renter.
